#### **Correction to Construction Ending Date on Approved Contract**

#### 1. RTA #20161637 - Market Street Shreveport, LLC, 509 Market Street, Shreveport

This contract was approved by the Board on October 25, 2017 with an estimated construction ending date of October 15, <u>2017</u>. The correct estimated construction ending date is October 15, <u>2018</u>. The company recognized their error after the contract was fully executed and notified LED staff to request a correction.

The original estimated dates were part of the application presented to the Board for consideration of contract approval. Changing the date requires a modification to Article V in the contract which states, "Contractee states the said project was to be completed on October 15, 2017..." A change in the approved contract terms must be approved by the Board.

With Board approval, the contract will be reissued with a revised estimated construction ending date of October 15, 2018.
