SPECIAL REQUESTS

• Nalco Company LLC application #20161839-ITE and Marathon Petroleum Company LP application #20180365-ITE were approved at the October 23, 2019 Board of Commerce and Industry meeting, and Louisiana Economic Development posted notice of the approvals on the Board's website on October 23, 2019 as required by rule, starting the 30-day period granted to the local bodies to either take action or provide notice of a public meeting. Notice of approval by the Board was also sent via e-mail and USPS.

The Notice of Actions from the St. John the Baptist Parish Council were provided to our office on November 15, 2019, notifying us of a meeting taking place on November 26, 2019. Because this date falls within the 30-day notice period provided by the rules, the Council gained an additional 30 days (for a total of 60 days from the start of the notice period) to conduct a public meeting and issue a resolution approving or rejecting the applications.

The St. John the Baptist Parish Council denied both applications at their November 26, 2019 meeting; however, LED did not receive notification of the denials within 3 days of the local action or the 60-day window. According to the ITEP rules, if a local entity does not take action or provide notice within the time delays provided, the applications are deemed approved. Upon receiving written request for a reconsideration of the approval by the council, LED is referring this matter to the Board of Commerce and Industry for their consideration.

• Myriant Lake Providence has an idled facility in Lake Providence with property that was subject to 24 Industrial Tax Exemption contracts. The company was granted a continuation of these contracts at the 9/12/2016 Board of Commerce and Industry (BC&I) meeting contingent upon receiving letters of support from the locals. LED received these letters and the 24 contracts remained active through 12/31/2017.

The 2016 Special Request indicated that LED recommended annual review and approval by BC&I, but the company made no subsequent request to continue 13 of the 24 contracts that were not otherwise scheduled to expire on 12/31/2017. Upon LED's conversation with Myriant, the company believed that property taxes have been being paid for all assets located at the site since 12/31/2017, and provided LED with proof of payments and related invoices. However, LED's review has only resulted in confirmation that taxes are being paid on the assets previously covered by the 11 contracts that expired 12/31/2017.

As of 2/11/2020, LED has not received documentation evidencing taxes being paid on all assets located at the Myriant Lake Providence location since 12/31/2017. Therefore, LED has informed both the company and the East Carroll Assessor that the 13 contracts at issue are deemed expired as of 12/31/2017. Upon request of the East Carroll Assessor for formal action of cancellation by the Board, LED is now requesting that the following contracts be cancelled with an expiration date of 12/31/2017: 20151777-ITE, 20151778-ITE, 20151779-ITE, 20151780-ITE, 20151781-ITE, 20151782-ITE, 20151783-ITE, 20151784-ITE, 20151785-ITE, 20151786-ITE, 20151789-ITE, and 20151789-ITE.

• Praxair, Inc. application #20190076-ITE was approved by the Board of Commerce and Industry at the December 13, 2019 meeting, following which Notice of Board Approval was sent to the St. James Parish Council, St. James Parish School Board, and St. James Parish Sheriff for their consideration.

On February 6, 2020, LED received the Notice of Action from the St. James Parish Council indicating: "St. James Parish Council has conducted a public meeting on Industrial Tax Exemption Application #20190076-ITE and voted to **DENY** the Application as presented by the Louisiana Department of Economic Development in the 12/12/19 Contract for Exemption of Ad Valorem Taxes with Praxair, Inc. Alternatively, St. James Parish Council has agreed to **APPROVE** Industrial Tax Exemption Application #20190076-ITE provided that the alternative yearly exemption percentages of ad valorem taxes as listed in the attached Resolution No. 20-40 are incorporated into the final Contract for Exemption of Ad Valorem Taxes with Praxair, Inc." The St. James Parish School Board and St. James Parish Sheriff returned Notices of Action to LED indicating the same action as the Parish Council.

The ITEP rules provide for only two options when a local governmental authority chooses to take action upon an ITEP application: Approve or Deny the Board-approved ITEP application.

- H. Upon the board's approval of an application, the department, on behalf of the board, shall, within three business days, transmit a copy of the approval and Exhibit A by mail or electronic mail to each local governmental authority and the assessor and the department shall post notice of the board's approval of an application on the department's website within three business days of approval, upon which date shall begin a notice period of 30 days for the parish governing authority (speaking on behalf of the parish and all parish bodies who are located outside the boundary of any affected municipality who receive a millage), the school board, any applicable municipality (speaking on behalf of the municipality and all municipal bodies who receive a millage) and the sheriff to initiate action to approve or reject the board's action as provided hereinafter.
- 1. Within the 30-day notice period, the parish governing authority, the school board, or any affected municipality may identify the application on the agenda of a public meeting notice and the sheriff may issue a letter approving or denying the application, and notice of these actions shall be given to the department within 3 business days. A local governmental entity that places the application on the agenda for a public meeting will have an additional 30 days (for a total of 60 days from the start of the notice period) to conduct a public meeting issuing a resolution approving or rejecting the board approved application, and notice of the issuance shall be given to the department within 3 business days. If a local governmental entity does not take action or provide notice as required herein, then the application will be deemed approved by each such entity.

LED interprets these responses from the St. James Parish locals as denials. However, because the Notices of Action received from the St. James Parish Council, School Board, and Sheriff are not the standard Notice of Action forms requested to be utilized for purposes of notifying the Department and Board of the outcome of local actions, LED is requesting the Board determine the result of the action taken by the St. James Parish Council, St. James Parish School Board, and St. James Parish Sheriff with regard to their Notices of Action returned to LED for the referenced project.
