Written Comments

Anyone unable to attend in person, or not comfortable at this time giving in-person testimony, due to COVID-19 and/or travel restrictions, may submit written comments prior to the meeting.

Public comments should be submitted to LED via email. These emails will be received up to 4:00 p.m., Tuesday, April 27, 2021. Emails must be submitted to: LEDBoardPublicComments@la.gov, and must include your name, organization represented, if any, agenda item and your comment. Written comments received within the allotted date/time will be included.

In-person Meeting Attendance Protocol

All persons attending the meeting in person shall practice appropriate protective health measures, social distancing and observe the below protocols:

1. The LaBelle room will be sanitized prior to the start of the meeting to ensure the safety of everyone in attendance. Everyone entering the LaBelle room must go through the temperature checkpoint located at the entrance of the board room. (Please allow extra time to go through the temperature checkpoint.) If you exit the meeting room and later re-enter, your temperature will be reassessed. Everyone entering the LaBelle room **MUST** practice social distancing and wear a face mask at all times. Once the allowed capacity for this room has been reached (50 people), you will be directed to an overflow area that will be set up in the LaSalle cafeteria. A

LED staff person will be stationed in the overflow area and will notify those waiting when seating in the main boardroom is available. Should a recess to the proceedings be called by the Board Chair, everyone in the overflow area will be made aware and advised of the start time after the break. SPECIAL REQUEST:

US Foods, Inc. – Enterprise Zone Application 20180231 (Jefferson Parish):

Due to project delays caused by high water levels along the Mississippi River, the applicant requests the Board to consider an extension of not more than two years to comply with its job creation requirement, in accordance with the below program provisions:

Statute:

La R.S. 51:1787

B (5)(a) Except as provided in Subparagraph (b) of this Paragraph, the business creates either:

(i) A minimum of the lesser of five net new permanent jobs to be in place within the first two years of the contract period, as determined by the company's average annual employment reported under the Louisiana Employment Security Law.

(ii) The number of net new jobs equal to a minimum of ten percent of the existing employees, minimum of one, within the first year of the contract period, as determined by the company's average annual employment reported under the Louisiana Employment Security Law.

(b) For purposes of Subparagraph (a) of this Paragraph, the methodology for determining a company's average annual employment shall be established by department rule.

(c) A business which has an estimated construction period for its building greater than two years may, for good cause shown, obtain an extension of not more than two years to comply with the requirements of Subparagraph (a) of this Paragraph.

Rule:

§701. Scope and Qualifications

E. Qualifications

1.a. To qualify for the enterprise zone program, a business must create permanent full-time net new jobs that are at least equal to the lesser of:

- i. five jobs, created within the first two years of the contract period; or
- ii. the number of jobs equal to a minimum of 10 percent of the employees employed throughout the United States by the business and its affiliates, a minimum of one, created within the first year of the contract period.

b. For good cause shown, the board may grant an extension of not more than two years to comply with the above job creation requirements.

US Foods, Inc., a national leader in foodservice distribution, recently acquired F. Christiana and is working on a large expansion project at the existing property in West Jefferson Parish of approximately 200,000 square feet. The expansion requires an estimated \$51.9 million investment in the new construction, building improvements, machinery & equipment and IT, and the addition of 45 new jobs.

Due to circumstances out of the control of the Company, US Foods is kindly requesting an extension of time to meet the minimum job creation requirements of the Enterprise Zone Program. Details regarding the delays experienced during construction can be found below, and additional information will be shared at the Commerce and Industry Board Meeting on April 28th, 2021. Thank you for your consideration on this matter.

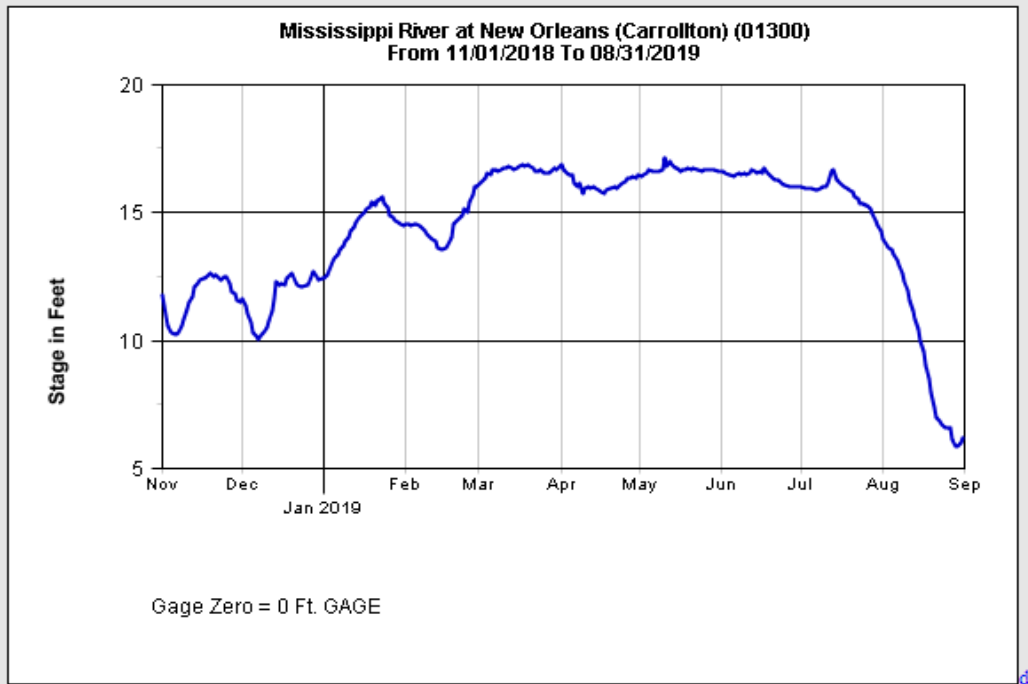
1. Past Delays:

- a. Please refer to the screenshots below. The first is taken from the construction schedule which identifies the start / finish / duration of the (2) river level occurrences which impacted the project. The 1st suspension delayed the start of the project for a duration of (179) work days, almost half a year. The 2nd suspension occurred while the project was in progress (94 days).

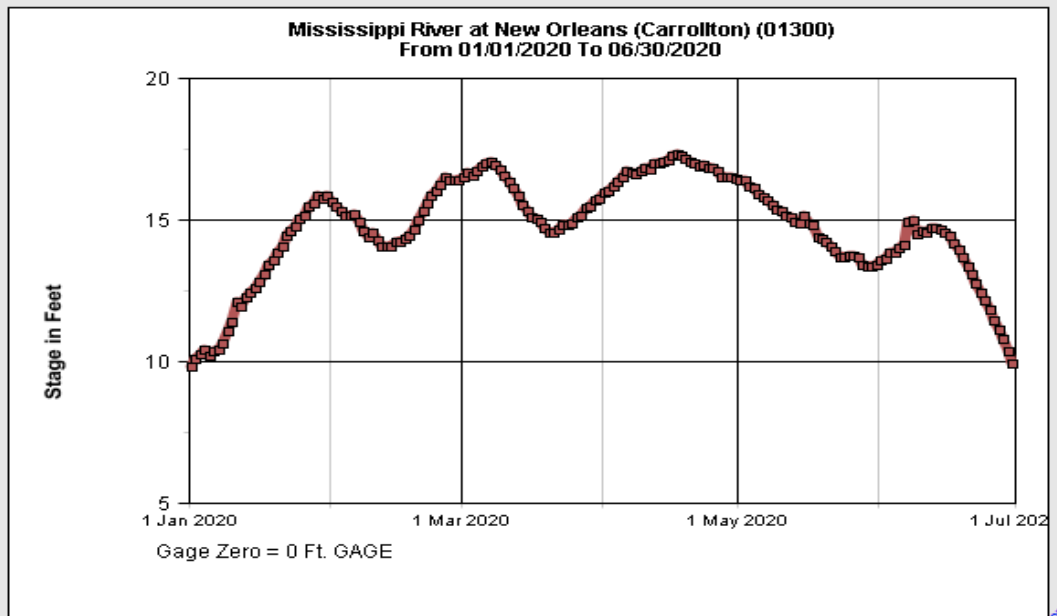

- b. In addition to the delays shown above, unfortunately, due to COVID-19, the Company was forced to place all active construction projects (nation-wide), on hold as of April 1, 2020. The hold was placed on this project until September 15th, 2020.

2. Future:

- a. Currently the Company is looking good for the newly projected completion date (June 2022) for the remaining phases. However, we still have to go through another Hurricane season, and there is always the possibility that the River could be at restriction levels when we are scheduled to drive piles and execute other sub-grade work on the last phase.

**** §503. Advance Notification; Application**

C. An application for tax exemption may be filed with the department on the prescribed form, subject to the following conditions:

6. If the application is submitted after the filing deadline, the term of exemption available under an initial contract and renewal thereof shall be reduced by one year for each year or portion thereof that the application is late, up to a maximum reduction up to the maximum remaining term. * §535. Sale or Transfer of Exempted Manufacturing Establishment

A. * §535. Sale or Transfer of Exempted Manufacturing Establishment

A. SPECIAL REQUESTS

Air Products and Chemicals, Inc. (Contract #20150876): On 12/16/2020, Air Products and Chemicals, Inc. submitted a Renewal Application stating the below change in manufacturing operations at the contract site:

From Renewal Application (received 12/16/2020):

- **If applicable, explain if any of the manufacturing activities or processes have been changed, modified, or eliminated since this contract was approved:** The project facility is located on the site of a refinery owned by our customer, Shell. On November 5, 2020, Shell announced it will shut down the Convent refinery while they continue to seek a buyer for the facility. Since Air Products' Convent SMR facility currently receives and supplies utilities with Shell's refinery, Air Products will be coordinating the shutdown of the SMR facility in December 2020 for an unknown period of time. Once operations stop, Air Products will place the plant in a "preservation" state, continuing to maintain the mechanical integrity and necessary permits, while Shell continues to market the refinery and Air 2/4 Products investigates possible transitioning to operations independent of the refinery. All Air Products employees will be maintained at the site into 2021, and once transitioned to the "preservation state", any excess employees will be redeployed to other Air Products production plants along the Mississippi River Corridor. Since the Convent SMR feeds Air Products' 600-mile LATX hydrogen pipeline system, Air Products' intent is to continue operations with a new owner of the refinery, or transition to operations independent of the refinery, once the necessary details are resolved.

Air Products and Chemicals, Inc. provided the below update on the manufacturing operations on 3/16/2021:

- We have stopped operating the plant and are in the process of executing preservation activities. This means we routinely inspect, maintain, and run equipment to ensure it remains fully functional and reliable if we start operating the plant again. Two of the five employees have been transferred to other Air Products' locations. The three remaining employees continue to work at the Convent plant performing the preservation activities.

§533. Reporting Requirements for Changes in Operations

A. OBD is to be notified immediately of any change which affects the tax exemption contract. This includes any changes in the ownership or operational name of a firm holding a tax exemption contract. A fee of \$250 shall be filed with a request for any contract amendment, including but not limited to, a change of ownership, change in name, or change in location. **The board may consider restrictions or cancellation of a contract for cessation of the manufacturing operation,** or retirement of any portion of the exempted equipment. Failure to report any material changes constitutes a breach of contract and, with approval by the board, shall result in restriction or termination.

APPEAL

Sommer Brothers Enterprises (Contract #20141045): LED received a request from Sommer Brothers Enterprises appealing the decision to deny their request for late renewal of tax exemption contract by the Board of Commerce and Industry at the February 24, 2021 meeting due to no company representative being present.

However, upon investigation post-meeting, LED discovered that the settings in place for the mechanism established for accepting written comments blocked external emails from reaching LED staff and Sommer Bros. did timely submit a letter for written comment explaining the late renewal and why they would not have a representative present at the meeting.

Furthermore, when the Renewal Application was received on 10/26/20 the company provided a statement from the Lafayette Parish Assessor's Office verifying taxes had not been paid on the assets associated with this contract since expiration. However, upon notification of the denial of the late renewal request in February 2021, Sommer Bros. stated that taxes had been paid on assets prior to 1/1/21.

§517. Assessed Property

A. The board shall not consider for tax exemption any manufacturing establishment or addition thereto once such establishment or addition has been in operation for a period of six months, unless the assessor of the parish in which the establishment or addition is located certifies in writing that said establishment or addition is not on the taxable rolls. If the establishment or addition is on the taxable rolls the board shall consider granting tax exemption only if the assessor agrees in writing to remove the establishment or addition from the taxable rolls should the tax exemption be granted.

B. The board shall not consider for tax exemption any property listed on an application on which ad valorem property taxes have been paid.

BOARD OF COMMERCE AND INDUSTRY

Upon consideration that an ITEP participant company's circumstances may change in ways unforeseen at the time of entering into Exhibit A's with LED, and in consultation with LED ITEP administrators and supervisors as well as the Secretary of LED, I make the following motion with regard to the Board's consideration of amendments to Exhibit A's requested by participant companies:

1. Prior to consideration by this Board of whether to approve an ITEP participant's amendment to an Exhibit A previously approved by the Board and participating local governmental entities, the ITEP participant shall first obtain approval by resolution from all of the participating local governmental entities (or letter by participating sheriffs) for any changes that would affect the following terms and conditions of the Exhibit A required by ITEP Rule s. 503(E) ("jobs, payroll or compliance term(s) or condition(s)"):
 - a. either the number of jobs and payroll to be created at the project site or the number of jobs and payroll to be retained at the project site where applicable (s. 503(E)(1)); and
 - b. the provision addressing the penalty for failure to create the requisite number of jobs and/or payroll at the manufacturing establishment (s. 503(E)(6)).
2. Amendments to jobs, payroll, or compliance terms or conditions will be prospective and applicable no earlier than the Project Year in which the Board approves the amendment.
3. For consistency of annual compliance determinations, in the event that any approval by a participating local governmental entity of an amendment to a jobs, payroll or compliance term or condition to an Exhibit A is different from an approval by another participating local governmental entity, then the most demanding term or condition approved by a participating local governmental entity will be the term or condition considered by the Board for final approval. For example, if a participating sheriff approves an amendment requiring 5 jobs and \$250,000 in payroll but the policy jury approves an amendment requiring 10 jobs and \$500,000 in payroll, then the Board will consider an amendment to require 10 Jobs and \$500,000 in payroll.
4. Amendments to Exhibit A's with regard to the following terms and conditions in Exhibit A's that are also required by ITEP Rule ss. 502 and 503(E) will not be considered by the Board:
 - a. changes to the definition of Jobs in the Exhibit A that are inconsistent with the definition of Job in ITEP Rule s. 502;
 - b. that the initial exemption contract shall be for a term of no more than five years and may provide for an ad valorem exemption of 80 percent, except that the initial exemption contract for mega projects shall be for a term of no more than five years and may provide for an ad valorem exemption of up to 93 percent (s.

503(E)(2));

- c. that the applicant can apply for a renewal exemption contract, the consideration of which will be based upon the applicant's performance during the initial term of the contract and that the renewal exemption contract shall be for a term of no more than five years and may provide for an ad valorem exemption of 80 percent, except that the renewal exemption contract for mega projects shall be for a term of no more than five years and may provide for an ad valorem exemption of up to 93 percent (s. 503(E)(3));
 - d. that the department, on behalf of the board, will notify the local governmental entities and the assessor when jobs and/or payroll requirements are not met in accordance with the exhibit A (s. 503(E)(4));
- 5. Any request by an ITEP participant for a substantive amendment to Exhibit A with regard to a term or condition not required by ITEP Rule s. 503(E) will be presented to the Board for consideration and the Board reserves the right to present those amendments to the participating local governmental entities for approval by all participating local governmental entities, without condition, and otherwise in accordance with current ITEP Rule 503(H).
 - 6. Requests for the Board to consider amendments to Exhibit A's will be made by special request to the ITEP Administrators.
 - 7. All as specifically set forth herein, I hereby enter this motion into the record and move that this motion be adopted by the Board for all ITEP projects subject to the rules promulgated by the Board in 2017 and 2018, as applicable.
