• Louisiana Green Fuels LLC (Contract #20210624-ITE):

Louisiana Green Fuels LLC is requesting to amend their existing Exhibit A agreement for Contract #20210624-ITE to add an additional year to the project in order to account for an additional year of assets coming into service (e.g. Phase Contract) earlier than originally anticipated when filing the "front-end" Application at the end of 2022.

From the Company: "In late 2022 Louisiana Green Fuels LLC filed a front-end application for 20210624-ITE, a \$1.9 billion biorefinery project that was originally intended to begin placing assets in service starting in 2025 and completing in 2028. The end date for asset capitalization has remained consistent with our original scope. However, the phases in which assets begin to be placed in service have moved up. Currently the company anticipates purchases that will be placed in service at the end of 2023. This requires us to submit our first Phase A application in early 2024 rather than in early 2026 as initially anticipated.

We would like to adjust this in the current Exhibit A. Therefore, we request that Exhibit A for 20210624-ITE be amended in Section 4.02 to reflect that assets will begin being placed in service in 2023 and continue through the previously established end date."

PCS Nitrogen Fertilizer LP is requesting to amend their existing Exhibit A agreement {Section 4.02(A)} for Contracts #20220103-ITE and #20220104-ITE to extend the originally proposed Commencement of Operation date of March 31, 2027 to March 31, 2030.

<u>From the Company:</u> "We originally planned for our expansion project to be operational in the spring of 2027, but we have encountered several unanticipated challenges during the project resulting from supply chain delays, higher inflation, interest rates and anticipated resource availability, and market downturns that have forced us to reevaluate our initial timeline.

We have currently invested more than \$100 million in the project and are actively pursuing the permits required to commence construction. At the conclusion of our project using current estimates, we will have spent over \$2 billion, created more than 35 new jobs, and expanded our annual payroll and state spend by millions of dollars. The project is still expected to meet our investment amount, new job, and new payroll ITEP compliance requirements. We hereby request permission to update our planned Commencement of Operations date to better reflect our current expected timeline."

Tax Equalization Request for Renewal of Contract

Company: Pool Corporation and subsidiaries

Covington, LA

St. Tammany Parish

Tax Equalization Program:

The Tax Equalization Program is an inducement which bolsters Louisiana's competitiveness to attract, retain, and encourage the expansion of manufacturing establishments, headquarters, and warehousing and distribution establishments to Louisiana, by way of equalizing the tax burden. This program is designed to eliminate the tax differential through the equalization of the overall taxes between a Louisiana site and a competing site in another state. The sites under consideration must be valid and viable for the proposed operations. The competing site must offer comparative advantages equal to or greater than the comparative advantages offered at the Louisiana site. The governor must extend a written invitation to the company authorizing the company to submit an application for this program.

The contract is for a period up to five years with the availability to apply for a renewal if all requirements have been met and the application was made prior to the termination of the contract. The tax equalization is determined on an annual basis based on the taxes payable in Louisiana and the taxes which would have been payable in the competing state. If the total tax liability of the contractee in Louisiana is greater than the total tax liability that the contractee would have incurred in the competing state, then the Louisiana tax liability shall be reduced by allowing an exemption to adjust the Louisiana tax burden to the tax burden the contractee would have incurred if it had located in the competing state.

Subsequent renewals for additional periods of five years or less may be granted to a contract holder whose contract has not expired as of the date of application for renewal. The applicant must demonstrate the conditions of the initial contract were met and the activities of the applicant in the State of Louisiana generate economic benefits to the state that exceed 20 times the Tax Equalization benefit for the year preceding the application for renewal. Such benefit to the state shall be determined by the application of nationally recognized multipliers as appropriate and set forth in the Regional Input-Output Modeling System ("RIMS II").
